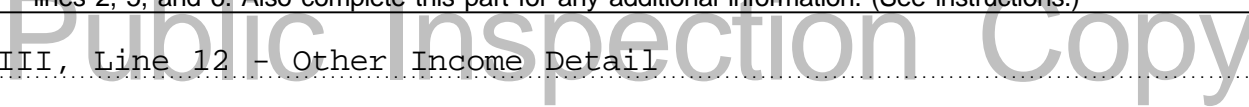

Amended Return Explanation

The Council's 2021 Form 990 was amended to correct several small misstatements of the organization's income and expenses in the reviewed financial statements prepared by the Council's previous independent accountant, which were the basis for the original Form 990 prepared by the organization's bookkeeper.

The successor independent accountant needed to reconstruct the calculations his predecessor used to prepare the Council's original 2021 reviewed financial statements. Because he was unable to complete this analysis before the extended filing deadline for the 2022 Form 990 Return of Organization Exempt from Income Tax, he prepared the original 2022 Form 990 from the client's QuickBooks trial balance without any year-end journal entry adjustments.

Only a small number of changes were needed for this amended filing. The most significant changes are the reduction of reported "Gross receipts" for 2022 by \$165 from \$307,465 to \$307,300 and the increase of "Revenue less expenses" by \$3,256 from \$27,523 to \$30,779, which corrected a misstatement of the opening accounts payable balance as of December 31, 2021.

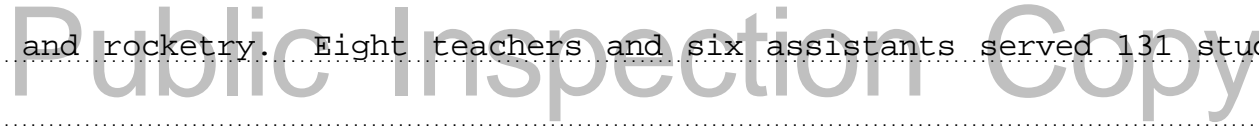
